I will notify the Club staff in writing of activities in which I do not wish my child to participate. In case of emergency if I, parent, guardian or emergency contact cannot be reached, I hereby give permission to the physician selected by the staff person to hospitalize, to secure proper treatment, and order injection, anesthesia or surgery as needed for my child as named above.

## Coronavirus
